3. BID GUARANTEE / EARNEST MONEY DEPOSIT

Bid Guarantee amount of *Rs.56,000.00* shall be submitted by a DD (for outstation firms) or Banker's cheque (in case of local firm) from a Nationalised Bank / Foreign Bank along with the bid, drawn in favour of "Centre for Cellular and Molecular Platforms, Bangalore". Alternatively, the BG amount may be submitted by way of Bank Guarantee from a Nationalised Bank/First Class Foreign Bank valid for 6 months. The BGA amount will be forfeited if the successful bidder fails to accept the Letter of Intent/ Purchase order or withdraws or amends impairs or derogates from the tender in any respect within the period of validity of this tender. The offers are liable to be rejected, at the discretion of the Centre, if they are not accompanied with BGA. No interest shall be payable by C-CAMP for BGA amount. The BGA shall be refunded to the unsuccessful bidders once the order is released on the successful bidder.

4. AUTHORITY OF AGENTS

In case where a bid is submitted by an Indian Agent on behalf of his foreign principal, such bid should be supported with a letter of Authority from the principal that the Indian Agent has been authorised to submit the bid on behalf of the principal. The indigenous manufacturers shall submit their bids directly.

5. PRICE

The price/s quoted shall be firm till the complete execution of the order. All details relating to price, price breakup, formula for price variation/escalation, inland transportation, documentation, taxes and duties, levies, Road/AIR/marine freight charges, delivery terms (exworks/F.O.R/F.O.B/C.I.F.) mode of payment, mode of despatch, insurance agency commission, if any, should be clearly stated. For indicating the price, the tenderers may choose any/all of the following:

- a) Ex-works (all other charges to be indicated separately).
- b) F.O.R. site (i.e. freight, packing & forwarding, loading on to the transport, documentation etc. included.) Internal transportation, freight, insurance, etc. to be shown separately.

7. VALIDITY OF BIDS

The bids shall be valid for a period of at least 180 days from the date of opening of the Price bids. Bids with shorter validity period are liable for rejection.

8. AGENCY COMMISSION

Agency Commission, if any, payable to the Indian Agent should be stated separately. The name and address of the Indian Agent shall be mentioned clearly. The agency commission will be paid to the Indian Agent directly in equivalent Indian Rupees immediately after complete satisfactory execution of the order on receipt of a claim from them. The bidder should clearly specify whether the price/s quoted is/are inclusive/exclusive of the agency commission.

9. DELIVERY

The tenderer should clearly mention the time required for supplying the item. The period of delivery will be counted (a) from the date of receipt of the order in case of Indian supplier and (b) from the date of opening of letter of credit/receipt of order (in the case of sight draft/advance draft) for foreign suppliers. The delivery date is the date at which the equipment should be delivered at C-CAMP.

10. PACKING

The item should be packed appropriately so that it can sustain transit hazards, multiple landing, warehousing, etc. during transit.

11. PLACE OF DELIVERY

In the case of items indigenously manufactured, ALL DELIVERIES shall be effected to the Centre for Cellular and Molecular Platforms, UAS-GKVK Campus, Bangalore-560065, whereas the foreign suppliers shall effect delivery up to Bangalore Airport, India by AIR only unless otherwise specified.

12. GUARANTEE/WARRANTY

The item/s covered under this tender shall be subject to a guarantee for trouble free performance, workmanship, material etc., fulfilling the specifications mentioned in this tender for 36 months from the date of commissioning. If any defect is found in the material, workmanship or performance during the guarantee period the same may either be repaired/replaced by the supplier as the case may be free of charge. The guarantee period for replacement of parts or repair work shall be same as above. A guarantee certificate to this effect should be forwarded to us with your invoice. For order placed on foreign suppliers, the supplier shall specifically confirm that their Indian representatives, if any, will provide with after sales service and will attend to any repairs or technical problems that may arise.

13. PERFORMANCE B/G

The successful bidder shall have to execute a performance B/G in accordance with the guarantee/warranty for 10% value of the order. This B/G has to be executed on an appropriate value of stamp paper in terms of a bank guarantee drawn on any nationalised bank or first class foreign bank and shall remain valid till the completion of the Defect Liability period/warranty period, with 6 months claim period.

14. TAXES AND DUTIES

The Centre shall deduct all taxes and duties, as applicable, from time to time from the bills payable.

15. PAYMENT TERMS

As per our Centre, 90% of the payment shall be made through Sight Draft (documents through bank) and balance 10% payable after installation, trail run and subject to acceptance by the group head through SAI and all other relevant documents, with Performance Bank Guarantee. All claims shall cease as per the Limitation Act.

16. CLARIFICATIONS

After opening the bids, if it becomes necessary for the purchaser to seek clarifications from the bidders, the same will be sought from the bidders. In such an event, the bidders will furnish all technical information / clarifications to the purchaser to reach on or before the due date fixed for that purpose indicating the Purchaser's tender reference. If the technical clarifications sought do not reach on or before the date date fixed, the bids shall be summarily rejected without any further notice.

17. RISK CLAUSE

Notwithstanding the other terms therein, the Centre at its option will be entitled to terminate the contract and to avail from elsewhere; at the risk and cost of contractor; either the whole of the contract or any part which the contractor has failed to perform within the time stipulated or if the same performance is not available, the best and the nearest available substitute thereof. The contractor shall be liable for any loss which the Centre may sustain by reason of such risk contract in addition to penalty.

18. DISPUTE AND RESOLUTION

Any dispute or differences between the parties that cannot be settled by mutual discussion at appropriate levels shall be referred to the sole arbitration of the Director, C-CAMP or his nominee and his decision in the matter shall be final and binding upon the parties to the dispute. The venue of arbitration proceedings shall be Bangalore and provisions of Arbitration Act for the time being in force in India shall be applicable. In respect of any matters pertaining to such arbitration, the courts of law in Bangalore will have exclusive jurisdiction.

19. OTHER TERMS

- a) If electrical/ AC/ technical works contract, appropriate license defining the required expertise from the approved Licensing authority.
- b) The Centre, will at its discretion ask for a solvency certificate from your bankers.

Technical Specifications - Deep freezer (-40°C)

Ultra Low Temperature, Vertical Upright type -40° C Deep Freezer

- 1. Ultra Low Temperature upright -40°C freezer suitable for storage of biological research samples.
- 2. Operating temperature range should be from -10°C to -40°C at ambient temperature of 35-degree C. It must maintain -40°C under normal working condition at ambient 35°C
- 3. System should be vertical standing and should have working volume of 550 Litres +/- 5%
- 4. System should be fully programmable microprocessor controlled with keypad and eye level control panel.
- 5. The system should be supplied with the suitable stabilizer.
- The system should have digital display. The digital display should be clear, easy to read LCD/LED touch screen to display all the parameters and alarms.
- 7. System should be equipped with precise temperature controller with accuracy of ± 1°C & it should maintain uniform temperature in freezer.
- 3. The system should have on board diagnostics, which allows quicker diagnosis of problem and minimizing downtime.
- 9. The system should have manual defrost
- 10. The system should have low/over voltage protection, surge protection to minimize potential damage from voltage spikes.
- 11. The system should be equipped with suitable Audio Alarm/buzzer and visual alarm for power failure, temperature deviation and other malfunctioning of system.
- 12. System should have at least four compartments with individual inner SS doors with independent door hinges and latches.
- 13. The system should have minimum 3 adjustable shelves
- 14. The door seal should be silicon based gasket with heater.
- 15. The system should have vacuum insulation with high density foam.
- 16. The system should have option for LN2 and CO2 back up system and chart recorder
- 17. The system should have forced air cooling to maintain the uniform temperature in the chamber
- **18.** System should have the latest refrigeration system. A suitable document should be produced by the supplier for the refrigeration system and type of gas.
- 19. System should have NO-NC contacts and BMS port for connection to remote monitoring system and for all the parameters required for monitoring.
- 20. The system should have user viewable data logging for power failure, door opening, temperature etc.
- 21. The system should have password protection to change the set parameters
- 22. The system should have access ports as standard to attach the external sensors.
- 23. The system should be efficient, silent suitable for indoor operation and must maintain sound level below 50 dB
- 24. The Freezer door must open at least 180 degrees for easy sample access.
- 25. System should have enhanced acoustic insulation with small foot print.
- **26.** The system should notify the user to perform preventative maintenance tasks including filter change and backup battery test.
- 27. The system should have castor wheel for easy movement.
- 28. The system should meet the international safety standards and CE, ISO 9001, ISO13485, USFDA Marked or equivalent marked.
- 29. System should be offered with minimum 3-year warranty as part of offer (not as extra item).
- **30.** System should have battery backup for controller, display and alarm.
- 31. System should have door handle and latch assembly with standard key lock.
- 32. System should be suitable for 230v, 50Hz single phase power supply.
- **33.** System should have pressure equalization part (PEP).
- 34. The vendor should have the base in Bangalore. Office address and service Engineer contact details should be enclosed with the quotation.
- 35. The quoted system should be CE/ISO Certified.
