System should be able to provide peltier driven heating and cooling, with mixing for different tube format 0.5ml – 50ml & Various plate format. 2. Temperature range: 15° below ambient to 100°C, with minimum setting of 1°C 3. Mixing frequency: 300-3000rpm 4. Incubation accuracy: ±0.5°C above ambient temperature 5. Instrument should be specifically designed to take care of cross contamination, by making sure spillage or lid wetting does not happen even at very low volumes 6. Instrument should have the flexibility to accommodate various tube formats from 0.5ml – 50ml tubes 7. It should also be possible to use various formats of plates like Microtiter plates, deepwell plates, ELISA plates, PCR 96 plates and PCR 384 plates 8. Instrument should be able to recognize the blocks automatically and their respective speed and temperature. 14. System should be stable on work bench even at the maximum speed with minimum noise levels 15. Instrument must have CE Certification & Three years warranty mandatory 16. 5. All duties, taxes, surcharge and cess as currently applicable must be stated in your quotation, separately. Otherwise your quote is liable to be rejected.
6. Your quotation should indicate delivery period & warranty period.
7. Delivery to be made to our stores. Please indicate charges, if any extra. Transit Insurance should be done upto CCAMP Stores.
8. If you are unable to supply the quality, specifications or brand as mentioned in our enquiry, please state so and then offer alternative to quality/specifications.
9. Payment: within one month after delivery & acceptance/satisfactory installation.
10. Please ensure that the enquiry number and the due date is superscribed on the envelope failing which your quotation is liable to be rejected.
11. **If the item is covered under DGS&D rate contract, please quote the rate as per the DGS&D rate contract with xerox copy of the DGS&D order.**
12. Any dispute or differences that may arise between the parties shall be referred to the sole arbitration of the Centre Director or his nominees.
