1	Supply of Fan filter unit: 315cfm flow capacity, of size-2feet x 2feet, filter: H-14 grade HEPA filter 99.995% efficiency on 0.3, with pre- filter of G4 grade with speed regulator as per the following. GAN FILTER UNIT, with min.315cfm flow capacity, of size Apprx. 2Feet x 2 feet, self-contained, with noise less than 55 db(A) at full speed and measured at 1 Mtr from the filter. The housing shall be made from at least 18-guage aluminum / 0.8mm SS, with an expanded metal faceguard on the downstream side Attached to the module, to a H-14 grade HEPA filter that provides 99.995% efficiency on 0.3 um particles. The unit shall also have a water washable pre-filter of G4 grade. The air circulation shall be maintained by a using a lightweight, backward curved/axial flow impeller powered by a 230V, 50Hz, SP Motor. The speed of the fan shall be adjusted by the solid-state speed regulator mounted on top of the housing. The FFU shall have provision for suspension mounting of the unit using screw rods from the ceiling.	2 Nos.

4. The validity of your quotation should be for 60 days from the due date.

5. All duties, taxes, surcharge and cess as currently applicable must be stated in your quotation, separately. Otherwise your quote is liable to be rejected.

6. Your quotation should indicate delivery period & warranty period.

7. Delivery to be made to our stores. Please indicate charges, if any extra. Transit Insurance should be done upto CCAMP Stores.

8. If you are unable to supply the quality, specifications or brand as mentioned in our enquiry, please state so and then offer alternative to quality/specifications.

9. Payment: within one month after delivery & acceptance/satisfactory installation.

10. The successful bidder shall have to execute a performance B/G in accordance with the guarantee/warranty for 3% value of the order. This B/G has to be executed on an appropriate value of stamp paper in terms of a bank guarantee drawn on any Nationalised Bank or first class Foreign Bank and shall remain valid till the completion of the Defect Liability period/warranty period, with 6 months claim period.

11. Please ensure that the enquiry number and the due date is superscribed on the envelope failing which your quotation is liable to be rejected.

12. If the item is covered under DGS&D rate contract, please quote the rate as per the DGS&D rate contract with xerox copy of the DGS&D order.

13. Any dispute or differences that may arise between the parties shall be referred to the sole arbitration of the Centre Director or his nominees. The decision of the arbitrator shall be final and binding on the parties. The venue for arbitration shall be Bangalore. The provisions of the Arbitration and Conciliation Act, 1996 as amended from time to time shall apply. The courts in Bangalore shall have exclusive jurisdiction to deal with any or all disputes between the parties
