- 6. Your quotation should indicate delivery period & warranty period.
- 7. Delivery to be made to our stores. Please indicate charges, if any extra. Transit Insurance should be done upto CCAMP Stores. 8. If you are unable to supply the quality, specifications or brand as mentioned in our enquiry, please state so and then offer alternative to quality/specifications.
- 9. Payment: within one month after delivery & acceptance/satisfactory installation.
